Allaying fears that after "WannaCrypt" ransomware, India will be targeted by a cryptocurrency malware attack that quietly but swiftly generates digital cash from machines it has infected, the country's cyber security unit on Thursday said India is safe from the "Adylkuzz" malware.

"There are no reports of this 'Adylkuzz' malware from the Indian establishments yet. Users are advised to maintain updated anti-virus software and apply patches to operating systems and applications on regular basis," Sanjay Bahl, Director General of the Computer Emergency Response Team (CERT-In), told IÀNS.

After facing a massive ransomware attack that exploited a vulnerability in a Microsoft software and hit 150 countries, the same Windows vulnerability (MS17-010) was also exploited to spread "Adylkuzz"

"Monero" -- being popularised by North Korealinked hackers -- is an opensource cryptocurrency created in April 2014 that foon cuses privacy, decentralisation and scalability.

It is an alternative to Bitcoin and is being used for trading in drugs, stolen credit cards and counterfeit

"There is no need to panic as "CERT-In publishes regular advisories and vulnerability notes on its website as well as some on Cyber Swachhta Kendra website", Bahl added.--IANS

Italian ship captain jailed over deadly accident

Genoa (Italy),

An Italian court on Wednesday handed a 10-year prison term to the captain of a cargo ship that slammed into the port in Genoa in 2013, toppling the control tower and killing nine people and injuring four

Jolly Nero captain Roberto Paoloni, got 10 years and four months in jail, while the ship's first officer Lorenzo Repetto got eight years and six months, its chief engineer Franco Giamoro got seven years and Genoa port pilot Antonio Anfossi got four years and two months.

The four men were found guilty of multiple culpable homicide, causing a building collapse and endangering transport security over the May 7, 2013 accident. There were howls of dismay in the courtroom from relatives of victims of the disaster when Giampaolo Olmetti, a director of Ignazio Messina & C. the company that owns the Jolly Nero, was acquitted. The court ordered Ignazio Messina & C. to pay a fine of 1,050,000 euros. Adele Chiello, the mother of Italian coastguard officer Giuseppe Tusa, who was killed in the accident condemned the "unjust" sentencing.

The Sensex has so far touched a high of 30,575.83 points and a low of 30,436.56 points during intra-day trade. The BSE market breadth was bearish -- with 1,747 declines and 755 advances."The equity benchmark indices started off the day on a weak note tracking bearish global cues. IDBI Bank reports major loss of Rs 3.200 crore for Q4

Mumbai,

State-owned IDBI Bank on Thursday reported its standalone net loss at Rs 3,199.76 crore for the fourth guarter (Q4) of 2016-17 ended March 31 -- a plunge of over 84 per cent -- from a net loss of Rs 1,735.81 crore reported during Q4 last fiscal.

The state-run bank's total income for Q4 fell by 2.74

per cent to Rs 8,048.12 crore compared to Rs 8,274.58 crore reported during the corresponding period of 2015-16. For the financial year ended March 31, the standalone net loss of the bank stood at Rs 5,158.14 crore compared to Rs 3,664.80 crore during 2016-17. However, the total income during the year under review rose to Rs 31,758.97 crore from Rs 31,453.46 crore reported in the financial year ended March 31, 2016.On a consolidated basis, the net loss of the staterun bank for the financial year ended March 31, 2017, stood at Rs 5,069.44 crore and the total income at Rs 31,972.57 crore.
