India driving more revenue per user for social media firms

New Delhi, As user growth on various social media platforms in the key global markets slows down, India is helping social media players clock more revenue per user in the Asia-Pacific region, thus driving the overall social advertising spend, a new report said on Monday.

Social video advertising spend will grow from \$17.6 billion in 2018 to \$56.5 billion in 2023 - a compound annual growth rate (CAGR) of 26.3 per cent, the report informed.

DoT to appoint e-auctioneer for 5G spectrum auction

New Delhi, The Department of Telecommunications (DoT) on Monday through its request for proposal (RFP) invited bidders to submit applications for selection of an agency to conduct the e-auction of 5G spectrum.

3.5 times the 2,354 MHz of spectrum offered at the previous auction in 2016, for which the total base price was Rs 5.63 lakh crore.
